## STAFF REQUEST FOR AMENDED ORDER

COMES NOW the Staff of the Missouri Public Service Commission and for its response to the Request for Amended Order states:

- 1. On January 7, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission to cancel 1-800-RECONEX, Inc.'s certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services in the state of Missouri and its accompanying tariff (Tariff No. 1, mistakenly numbered as Tariff No. JX-2004-0411). In File No. TA-2001-389, the Commission granted RECONEX ("the Company") a certificate to provide interexchange and nonswitched local exchange telecommunications service.
- 2. On February 1, 2010, the Commission cancelled the Company's certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services in the state of Missouri and its Tariff No. 2 (Tariff No. JX-2004-0411).
- 3. The Staff has since learned that the Company was also certificated to provide basic local telecommunications on March 18, 1999 in File No. TO-99-177, and had three tariffs, PSC Mo No.1, Tariff No. JC-2004-0410; PSC Mo No.2, Tariff No. JX-2004-0411 (cancelled by the Order Cancelling Certificate); and PSC Mo No.3, Tariff No. JC-2004-0412.
- 4. In light of the file designation in this matter, and the fact that the Company received its certificates in two cases at different times, the Commission may determine that a separate file designation is appropriate to cancel the Company's basic local telecommunications service authority. If that is the case, then the Staff incorporates its Motion to Cancel Service Authority and Accompanying Tariff as if fully set forth herein.

WHEREFORE, the Staff requests that the Commission either amend its Order in this matter to cancel the Company's basic local telecommunications certificate and PSC Mo. Nos. 1 and 3,

Tariff Nos. JC-2004-0410 and JC-2004-0412, respectively, or cancel the certificate and tariffs in a new case as the Commission may designate.
