## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: February 18, 2011 Effective Date: February 28, 2011

On December 30, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting DSLnet Communications, LLC ("DSLnet") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-99-395, the Commission granted DSLnet a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that DSLnet has reported no jurisdictional revenue in annual reports for the years 2008 and 2009. Staff notes that it is not in the public interest to allow telecommunication companies to retain their certificates of service authority if they have not conducted business in Missouri for over a year. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On January 19, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than January 31, 2011. By letter dated January 31, 2011, DSLnet voluntarily relinquished their certificate and accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the company's response to voluntarily relinquish the certificate, the Commission finds that the certificate of service authority and accompanying tariff granted to DSLnet Communications, LLC shall be canceled.

## IT IS ORDERED THAT:

- The certificate of authority to provide interexchange telecommunications services granted to DSLnet Communications, LLC, in File Number TA-99-395, is canceled.
  - 2. DSLnet Communications, LLC's tariff, P.S.C. Mo No. 1, is canceled.
  - 3. This order shall become effective on February 28, 2011.

4. This case may be closed on March 1, 2011.
