**NOTICE OF SUBSTITUTION TO STAFF ACCOUNTING SCHEDULES**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its Notice of Substitution to Staff Accounting Schedules ("Notice to Substitute") states as follows:

1. On August 18, 2008, Staff filed its Staff Accounting Schedules in this case.
2. On August 25, 2008, Staff discovered a clerical error in Staff's Accounting Schedule for the Cedar Hill Sewer District excess capacity adjustment.
3. In Staff's original Accounting Schedules filing, the Staff proposed an excess capacity adjustment for the Cedar Hill Sewer District. This adjustment was to remove plant from rate base in the amount of \$2,179,907. However, due to the clerical error in the Staff's Accounting Schedule for the Cedar Hill Sewer District, the negative adjustment was reversed and an additional \$2,179,907 of plant was added to rate base. This incorrect number flows through to the Total Company Summary Staff Accounting Schedules.
4. The attached substitute pages, labeled as Attachment A, revise and replace the Total Company Summary Staff Accounting Schedules and the Cedar Hills Sewer District Staff Accounting Schedules.
5. Staff therefore submits this Notice to Substitute the Total Company Summary Staff Accounting Schedules and the Cedar Hills Sewer District Staff Accounting Schedules of the

original Staff Accounting Schedule pages with the attached revised schedule pages. See Attachment A.
