

SECTION 3 - DESCRIPTION OF SERVICE, Continued**3.3 Telecommunications Services**

Company provides a switched telecommunications service, which allows a customer to establish a communications path between two stations by using uniform dialing plans. Calls are billed in six (6) second increments. A thirty (30) second initial billing minimum is applicable on each call.

- 3.3.1 **Network Plus Switched Access Service** is a switched access service, offering users both outbound 1 plus and inbound, toll free long distance telecommunications services. The service offers direct dial capabilities of other underlying carrier(s) network services.
- 3.3.2 **Network Plus Travel Card** is a calling card service enabling Switched Access Service subscribers to place calls from any touch tone phone in the U.S. Travel Card calls are billed at the Company's rates and appear on the subscriber's monthly long distance bill.
