ORDER GRANTING MOTION REGARDING SERVICE OF PROCESS

On February 2, 2005, the Missouri Public Service Commission issued an Order Canceling the Certificate of Service Authority and Accompanying Tariffs of Operator Communications, Inc., d/b/a Oncor Communications, Inc. The Order has an effective of February 12, 2005. On February 9, 2005, the Staff of the Commission filed a Motion requesting that the Commission extend the effective date of the order by an additional ten days.

In its Motion, Staff explains that Oncor's address was incorrect and that the correct address has recently been obtained. Although now aware of the Commission's action, the company is not expected to object its certificate being cancelled. However, Staff seeks to extend the effective date of the Commission's order, presumably to allow the Company a fair opportunity to respond.

If done so prior to the effective date, Commission rule 4 CSR 240-2.050(3)(A) allows the Commission to extend the effective of its order. The Commission finds that Staff's request is reasonable and will grant the requested relief.

IT IS THEREFORE ORDERED:

1. That the Staff of the Commission's Motion Regarding Service of Process is granted.
2. That the effective date of the Commission's Order Canceling Certificate of Service Authority and Accompanying Tariffs, issued on February 2, 2005, is extended from February 12 to February 22, 2005.
3. That this order shall become effective on February 10, 2005.



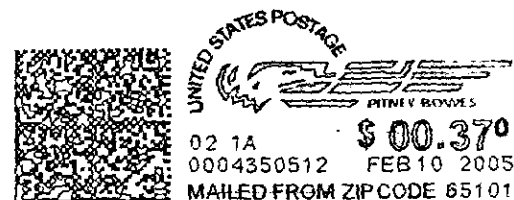
