**MOTION TO CANCEL CERTIFICATE
OF SERVICE AUTHORITY AND TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority in Missouri of Zoom-i-Net Communications, Inc. ("the Company") and states as follows:

1. On May 14, 2005, the Commission granted a certificate of interexchange service authority pertaining to the Company in Case No. XA-2005-0314. It has an existing approved tariff, YX-2013-0475.

2. On May 19, 2015, the Company notified the Commission that it no longer wished to retain its certification to provide interexchange telecommunications services in Missouri (see the attached).

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex*

Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications service in Missouri and the tariff of Zoom-i-Net Communications, Inc.
