MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority of iNetworks Group, Inc., (Company) and states:

- 1. On September 15, 2010, the Commission granted a certificate of interexchange service authority, basic local exchange telecommunications service and switched exchange access services in Case No. LO-2011-0021, to the Company. The Company has an existing tariff, No. YL-2011-0046.
- 2. Section 392.611(2) requires telecommunications providers to submit an annual report to the Commission along with other necessary information to calculate assessments. The requirements telecommunications providers must meet are further explained and codified in 4 CSR 240-28.040 (reporting) and 4 CSR 240-28.050 (assessments).
- 3. The Company has failed to send its required 2017 Annual Report. An email to the Company regarding the Annual Report came back as a failure to send because that email address could not be found. Staff reached out to a prior known associate of the Company, which indicated the Company was administratively dissolved on February 15, 2017 for failure to file its registration

with the Missouri Secretary of State. Staff has been unable to reach a Company contact under any other circumstances.

- 4. Due to the Company's failure to comply with the applicable statutes, rules and orders, Staff moves for the Commission to cancel the Company's certificate of service authority to provide interexchange service authority, basic local exchange telecommunications service and switched exchange access services along with the accompanying tariff.
- 5. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 6. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange service authority, basic local exchange telecommunications service and switched exchange access services in Missouri and the applicable tariff of iNetworks Group, Inc.
