ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY OF CTC COMMUNICATIONS CORPORATION d/b/a EARTHLINK BUSINESS

On July 26, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificate of service authority of CTC Communications Corporation d/b/a EarthLink Business ("Company") to provide interexchange telecommunication service in the State of Missouri be cancelled at the Company's request. On November 4, 2011, the Commission had granted the Company a certificate of service authority to provide interexchange telecommunication service in the State of Missouri in Case Number XN-2012-0105.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ On July 27, 2018, the Commission issued its Notice that anyone wishing to respond to Staff's Motion or wishing to request a hearing should do so by filing a pleading with the Missouri Public Service Commission no later than August 7, 2018. No such

request or filing was received by the Commission. Therefore, the Commission may cancel the certificate based on Staff's motion.

THE COMMISSION ORDERS THAT:

1. The Company's certificate of service authority to provide interexchange telecommunication service in the State of Missouri is herewith cancelled.
2. The Missouri Public Service Commission Data Center may close this file upon the filing of this Order.
3. This Order shall be effective when issued.
