ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On July 26, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificate of service authority of CTC Communications Corporation d/b/a EarthLink Business (“Company”) to provide interchange telecommunication service in the State of Missouri be cancelled at the Company’s request. On November 4, 2011, the Commission had granted the Company a certificate of service authority to provide interchange telecommunication service in the State of Missouri in Case Number XN-2012-0105.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff’s motion is received, the Commission may cancel the certificate based on Staff’s motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
