On October 2, 2018, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interchange service authority and the applicable tariff of NobelTel, LLC (Company) in the State of Missouri. On November 8, 2002, the Commission granted the Company a certificate to provide intrastate interexchange service in Case No. XA-2003-0119. The Company has a currently effective tariff, Tariff No. JX-2003-1049. The Staff's motion states that the Company wishes to voluntarily relinquish its authority and to have all of its applicable tariffs cancelled.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
