ORDER ESTABLISHING TIME TO RESPOND

On March 24, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificate of service authority to provide interexchange telecommunications services of Voicecom Telecommunications, LLC. The Commission granted Voicecom Telecommunications, LLC a certificate of service authority in File No. XA-2006-0178.

Sections 392.210 and 392.390, RSMo set forth various requirements for telecommunications companies. The requirements include filing an annual report and a Statement of Revenue report.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 3, 2023.
2. This order shall be effective when issued.
