SECOND ORDER RE-ESTABLISHING TIME TO RESPOND

Background of Mailings

This is the Commission's third order attempting to provide notice, which has thus far been mailed unsuccessfully. The first order issued and mailed on March 24, 2023.¹ The address the Commission used appeared to be an amalgamation of two addresses, and the posted mail was returned on May 3.

The second order issued and mailed on May 12. This order employed an address found online, 8200 Greensboro Dr. Suite 900 McLean, Virginia.² The posted mail was returned on June 9. This order supersedes the prior two orders, and will establish time for a response.

Main Order

On March 24, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificate to provide interexchange and non-switched local exchange telecommunications service authority and currently active tariff of Norstar Telecommunications, LLC. The Commission granted Norstar Telecommunications, LLC a certificate to provide interexchange and non-switched local exchange telecommunications service authority in File No. XA-2007-0482.

Sections 392.210 and 392.390, RSMo set forth various requirements for telecommunications companies. Those requirements include filing an annual report, filing a Statement of Revenue report, and paying the Missouri Commission assessment.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.³ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 30 days from the issuance of this order to respond or file a motion for hearing. This order will be sent to the address listed in the 2019 annual report,⁴ the address from the application for a certificate of service, as well as the address for the registered agent.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than July 24, 2023.
