# ORDER ESTABLISHING TIME TO RESPOND TO MOTION

Issue Date: June 5, 2023 Effective Date: June 5, 2023

On May 31, 2023, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange telecommunications service authority and applicable tariff of National Access Long Distance, Inc. ("the Company"). On August 14, 2003, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. XA-2003-0586. The Company also has an applicable tariff, Tracking No. YX-2003-2237. Staff's motion stated that the Company wishes to cancel the certificate and applicable tariff. The Company stated that it no longer offers telecommunications services in Missouri and that no customers will be affected.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
