STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize the change of name of AmeriVon LLC to V-Global Communications, LLC.

2. The company has fulfilled the requirements of the Commission's rule governing name changes at 4 CSR 240-2.060(5) in that the request contains a clear statement of the old and new names. On September 10, 2008 the Company filed an amended certificate of authority of a foreign corporation issued by the Missouri Secretary of State, and revised tariff sheets with the new name.

3. This Company currently has no Missouri customers, thus the customer notification provision of 4 CSR 240-3.545(20) is not applicable.

4. The company has submitted a new tariff with an effective date of September 19, 2008. Staff has reviewed the new tariff and recommends that the Commission approve it.

WHEREFORE, Staff recommends that the Commission issue an order acknowledging that AmeriVon LLC to V-Global Communications, LLC and will do business under that name; approving the new tariff, MO PSC No. 1, Revised Page No. 1, filed in conjunction with this case.
