# ORDER CANCELLING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY

Issue Date: June 28, 2023 Effective Date: July 28, 2023

On May 31, 2023, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority to provide intrastate interexchange telecommunications service and applicable tariff of Nationwide Long Distance Service, Inc. ("the Company"). On June 4, 2006, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. XA-2006-0409. The Company also has an applicable tariff, Tracking No. YX-2006-0803. Staff's motion stated that the Company wishes to cancel the certificate and applicable tariff. The Company stated that it no longer offers telecommunications services in Missouri and that no customers will be affected.

On June 5, 2023, the Commission issued an order that anyone wishing to file an objection or request a hearing do so no later than June 15, 2023. There were no such filings. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. Therefore, the Commission will cancel the certificate based on Staff's motion.
