## ORDER CANCELING TARIFF

On November 21, 2017, the Commission's Staff filed a Motion to Cancel Tariff. Staff states the Commission previously canceled the authority of Coast International, Inc. ("Coast") to resell telecommunications services. Since that Commission order, Staff became aware that Coast had a corresponding tariff. Staff now asks the Commission to cancel that tariff.

Commission Rule 4 CSR 240-2.080(13) states that parties have ten days to respond to pleadings unless otherwise ordered by the Commission. Ten days have elapsed since Staff filed its motion, the Commission issued no order to the contrary, and Coast has not responded. Thus, the Commission will take up Staff's motion unopposed.

The Commission finds Staff's motion reasonable, and will grant it..

### THE COMMISSION ORDERS THAT:

1. The above-referenced tariff, Tariff No. JX-2003-0450, is canceled.
2. This order shall be effective on December 18, 2017.

3. This file shall be closed on December 19, 2017.


