ORDER CANCELING CERTIFICATES AND TARIFFS

Effective Date: September 17, 2007

On April 13, 2007, Trinsic Communications, Inc., Touch 1 Communications, Inc., and Matrix Telecom, Inc., filed a joint application for the transfer of Trinsic's and Touch 1's assets used to provide local and long distance telecommunications services to Matrix. On May 31, 2007, the Commission approved the transfer of assets from Trinsic and Touch 1 to Matrix and approved Matrix's tariffs. The Commission directed the applicants to notify the Commission when the transactions were complete so that Trinsic's and Touch 1's certificates and tariffs could be canceled. On August 30, 2007, Matrix notified the Commission that the transfer of assets has been completed.

The Commission has the authority to cancel a telecommunications corporation's certificate under Section 392.410.5, which states: "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The transactions authorized by the Commission's May 31, 2007 order have been completed. The Commission will therefore cancel the certificates and the associated tariffs of Trinsic and Touch 1.

IT IS ORDERED THAT:

1. Touch 1 Communications, Inc.'s certificate of service authority to provide interexchange telecommunications services in Missouri, issued in Case No. TA-95-76 on November 8, 1994, is canceled.

2. Touch 1 Communications, Inc.'s interexchange service tariff (Tariff No. JX-2003-0877) is canceled.

3. Trinsic Communications, Inc.'s certificates of service authority to provide basic local exchange telecommunications service, issued in Case No. TA-98-572 on November 17, 1998, and interexchange telecommunications services, issued in Case No. TA-99-15 on November 9, 1998, are canceled.

4. Trinsic Communications, Inc.'s tariffs for interexchange service (Tariff No. YL-2005-0447), resale and facilities-based competitive local exchange service (Tariff No. YL-2005-0448), access services (Tariff No. YL-2005-0449), and wholesale services (Tariff No. YL-2005-0536) are canceled.

- 5. This order shall become effective on September 17, 2007.
- 6. This case may be closed on September 18, 2007.
