INFRASTRUCTURE REPLACEMENT SURCHARGE (ISRS)

<u>Description</u>: Rate ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of sections 393.1009, 393.1012 and 393.1015, RSMo.

Applicability: Rate ISRS is applicable to each customer billing for service during the effectiveness of the ISRS rate element.

ISRS Rate Element: In addition to the other charges provided for in the Company's tariff, a monthly ISRS Rate Element shall be added to each bill for service on and after the effective date of the ISRS rate. The amount of the ISRS Rate Element, by customer class, is as follows:

Residential	\$2.40 per month	*
Small General Service	\$3.55 per month	*
Large General Service	\$12.05 per month	*
Large Volume Service	\$94.49 per month	*
Whiteman Air Force Base	\$94.49 per month	*
