**ORDER CANCELING CERTIFICATE**  
**AND ACCOMPANYING TARIFFS**

Issue Date: June 27, 2006

Effective Date: July 7, 2006

On May 23, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariffs of Telefyne Incorporated, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-2001-683, the Commission granted Telefyne a certificate of service authority to provide intrastate interexchange telecommunications services. Telefyne's tariffs, PSC Mo No. 1 and PSC Mo No. 2, were also approved.

Staff's motion states that Telefyne indicated in its confidential Statement of Revenue that it is no longer in business and no longer wished to maintain its operating certificate in Missouri. Furthermore, Telefyne reported no Missouri jurisdictional revenue. Telefyne failed to file its annual registration report according to the Missouri Secretary of State's office, and its authority to do business in the State of Missouri was revoked on January 14, 2002. Staff

recommends that the Commission cancel the company's certificate of service authority and accompanying tariffs, PSC Mo No. 1 and PSC Mo No. 2, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Telefyne's request to cancel the certificate and tariffs included in its Statement of Revenue, the Commission finds that the certificate of service authority and accompanying tariffs granted to Telefyne Incorporated, shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Telefyne Incorporated, in Case Number TA-2001-683 is canceled.
2. Telefyne Incorporated's tariff, PSC Mo No. 1, is canceled.
3. Telefyne Incorporated's tariff, PSC Mo No. 2, is canceled.
4. This order shall become effective on July 7, 2006.

5. This case may be closed on July 8, 2006.
