Enclosed for filing with the Missouri Public Service Commission ("Commission") on behalf of Missouri-American Water Company ("MAWC"), please find, in electronic format, a new sewer tariff (P.S.C. MO No. 26). The purpose of this filing is to create a consolidated sewer tariff that provides the rates, rules, and regulations applicable to all MAWC sewer customers.

This tariff has resulted from a workgroup established as a result of Case No. WR-2015-0301. The Non-Unanimous Revenue Requirement Stipulation and Agreement,¹ in Case No. WR-2015-0301, stated, in part, as follows:

MAWC, Staff, OPC, and any other interested party, will participate in a sewer tariff workgroup, for the purpose of developing a single sewer tariff document that will replace current MAWC sewer tariffs and be applied to any future MAWC sewer service area.

The sewer tariff workgroup has held several workshops and has exchanged several draft tariffs over the last several months. The attached P.S.C. MO No. 26 represents the product of that workgroup, and is hereby filed for Commission approval.

Each of the tariff sheets, as listed herein, bears an issue date of April 5, 2017, and a proposed effective date of May 5, 2017. The P.S.C. MO No. 26 tariff book is designed to
