ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: July 27, 2005

Effective Date: August 6, 2005

On July 11, 2005, the Staff of the Missouri Public Service Commission filed a motion to cancel the certificate of service authority granted to Norstar Communications, Inc., d/b/a Business Savings Plan, Inc. Staff also requests that the Commission cancel the company's tariff.

Staff informs the Commission that the company was granted a certificate of service authority to provide interexchange telecommunications services in Case No. TA-2001-337. In the same case, the Commission approved the company's tariff, Missouri P.S.C. Tariff No. 1.

In support of its motion, Staff informs the Commission that the Missouri Secretary of State's website reports that the certificate of authority granted to the company was revoked on February 19, 2004, because the company failed to file its Annual Registration Report. Staff also states that mail delivered to the company's address has been returned as undeliverable. Also, Staff has attempted to contact the company using the telephone number provided to the Commission. Staff states that having reached an answering

machine, the number appears to be a residential number that does not reference any corporate entity.

Staff also states that the company appears to have never served any customers because the Commission has never assessed the company for more than \$0.00. Furthermore, the company failed to submit annual reports for 2003 and 2004 and stopped providing Statements of Revenue after fiscal year 2004.

Commission Rule 4 CSR 240-2.080(15) states that parties shall not be allowed more than ten days in which to file a responsive pleading. More than ten days have expired since Staff filed its motion, yet the company has not responded.

Section 392.410(5), RSMo 2000, states that "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected. . . . " The Commission has reviewed Staff's motion and finds that granting the motion is reasonable. The Commission will cancel the certificate of service authority granted to Norstar Communications, Inc., d/b/a Business Savings Plan, Inc., in Case No. TA-2001-377. The Commission will also cancel the company's tariff.

IT IS THEREFORE ORDERED:

1. That the certificate of service authority to provide interexchange telecommunications services granted to Norstar Communications, Inc., d/b/a Business Savings Plan, Inc., in Case No. TA-2001-377, is canceled.

2. That the tariff, Missouri P.S.C. Tariff No. 1, approved in Case No. TA-2001-377, is canceled.

3. That this order shall become effective on August 6, 2005.

4. That this case may be closed on August 7, 2005.
