ORDER CANCELING CERTIFICATES AND CANCELING TARIFFS

Issue Date: July 28, 2005 Effective Date: August 7, 2005

This order cancels the certificates of service authority to provide basic local, local exchange, and interexchange telecommunications services granted to Teligent Services, lnc., along with its accompanying tariffs.

On June 14, 2005, the Staff of the Missouri Public Service Commission filed its motion to open a case and cancel Teligent's certificates of service authority. Staff stated that the Commission granted Teligent certificates of service authority to provide intrastate basic local and local exchange telecommunications services in Case No. TA-2000-578. The Commission granted Teligent a certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services in Missouri in Case No. TA-2000-581. The Commission also approved Teligent's tariffs, Tariff MO P.S.C. No. 1, Tariff MO P.S.C. No. 2, and Access Service Tariff No. 3 – Missouri.

Staff reported that in a letter received by the Commission on February 3, 2005, Teligent requested that its certificates be canceled. The letter was signed by Jennifer Martin, Manager, Regulatory Affairs, for the company.

Staff noted that Teligent had no Missouri customers when it sold its customer base to another company on December 31, 2004. Staff also reported that Teligent failed to submit its 2004 annual report but that it is otherwise in good standing with the Commission and the Missouri Secretary of State and owes no assessments. Staff, therefore, recommends that Teligent's certificates and accompanying tariffs be canceled.

The Commission has the authority to cancel a telecommunications corporation certificate under Section 392.410.5, which states, "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Since no one has requested a hearing in this case, the Commission may grant the relief requested based on the application.

The Commission has reviewed the motion and finds that it is reasonable to cancel Teligent's certificates. In addition, the Commission finds that it would be in the public interest to cancel the tariffs of the company. Therefore, the certificates of service authority granted to Teligent in Case Nos. TA-2000-578 and TA-2000-581, along with the accompanying tariffs, will be canceled.

IT IS THEREFORE ORDERED:

That the certificates of service authority granted in Case Nos. TA-2000-578
and TA-2000-581 to Teligent Services, Inc., along with the accompanying tariffs, Tariff
MO P.S.C. No. 1, Tariff MO P.S.C. No. 2, and Access Service Tariff No. 3 – Missouri, are
canceled.

- 2. That this order will become effective on August 7, 2005.
- 3. That this case may be closed on August 8, 2005.
