**ORDER RECOGNIZING NAME CHANGE
AND APPROVING TARIFF SHEETS**

On July 1, 2011, the Commission received the above-referenced requests for name change. They were filed pursuant to Commission Rule 4 CSR 240-2.060(5). Accompanying the requests were the above-referenced tariff, which bear an effective date of August 8, 2011.

On July 27, 2011, Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the tariff sheets.

The Commission has reviewed the application, finds that it substantially complies with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), and finds that it should recognize the name change. The Commission will also approve the revised tariff.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Qwest Communications Company, LLC to Quest Communications Company, LLC d/b/a CenturyLink QCC.

2. The Commission approves the tariff sheets Quest Communications Company, LLC d/b/a CenturyLink QCC filed on July 1, 2011, reflecting its new name. Those tariff sheets were assigned tariff file number JX-2012-0005 and JC-2012-0006, and are approved for service on and after August 8, 2011. The tariff sheets approved are:
