Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed tariff revisions to extend Missouri Energy Efficiency Investment Act (MEEIA) Cycle 3 programs an additional year pursuant to an agreement approved by the Commission on December 14, 2022, along with a motion for expedited treatment. Evergy's motion for expedited treatment asks the Commission to allow its tariff sheets to take effect on January 1, 2023, prior to the tariff sheets' proposed effective dates of January 11, 2023, and January 12, 2023. In support of its motion, Evergy states that it filed some tariff sheets to extend certain MEEIA programs, but, due to an administrative error, it inadvertently did not file some tariff sheets necessary to avoid any gaps in certain other MEEIA Cycle 3 program.

The Commission directed its Staff (Staff) to file a recommendation, and set a deadline for any other responses to Evergy's tariff sheets. Staff recommends approval of the tariff sheets. No other responses were received.

The Commission has reviewed the tariff sheets and finds that they should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets to prevent any gaps in the MEEIA programs. The Commission will approve Evergy's tariff sheets to become effective on January 1, 2023. In addition, the Commission finds it reasonable under Section 386.490.2, RSMo, to make this order effective in less than 30 days so that the order will be effective concurrently with the tariff sheets.

THE COMMISSION ORDERS THAT:

- 1. Evergy's motion for expedited treatment is granted.
- 2. The following tariff sheets filed by Evergy and assigned Tariff Nos.
