# ORDER APPROVING COMPLIANCE TARIFF

Issue Date: May 3, 2011 Effective Date: May 9, 2011

The Missouri Public Service Commission is approving the pending tariff sheets.

Effective February 14, 2011, the Commission required the applicant to file tariff sheets ("tariff") in the Commission's *Order Granting Application and Requiring Filing of Tariff.* In compliance with the Commission's order, the tariff arrived at the Commission's office on March 25, 2011. On April 28, 2011, the Commission's staff filed its recommendation, with a supporting affidavit, recommending approval of the tariff. No law requires a hearing before making a decision on the tariff<sup>1</sup> and no party disputes the tariff. Therefore the Commission convened no hearing, need not separately state its findings of fact, and bases its findings on the verified filings. <sup>2</sup>

On that basis, the Commission will approve the tariff.
