ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 23, 2017 Effective Date: June 2, 2017

On May 15, 2017, 1 800 Collect, Inc., d/b/a Simple Billing Solutions ("Simple Billing") filed notice that it was discontinuing services and asked the Commission to cancel its certificate of service authority and accompanying tariff to provide telecommunications services in the State of Missouri.

In File Number XA-2012-0190, the Commission granted Simple Billing a certificate of service authority to provide interexchange telecommunications services in the State of Missouri, and approved its tariff. The Company's tariff, P.S.C. MO No. 1 was also approved.

On May 17, 2017, the Commission issued an Order Directing Staff to File a Recommendation. On May 22, 2017, Staff filed its recommendation and stated that Simple Billing notified the Commission that it no longer wished to retain its certificate to provide telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Simple Billing's request and Staff's recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to 1 800 Collect, Inc., d/b/a Simple Billing Solutions, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide interexchange telecommunications services granted to 1 800 Collect, Inc., d/b/a Simple Billing Solutions, in File Number XA-2012-0190, is canceled.
- 2. 1 800 Collect, Inc., d/b/a Simple Billing Solutions' tariff, P.S.C. MO No. 1, is canceled.
 - 3. This order shall become effective on June 2, 2017.
 - 4. This case may be closed on June 3, 2017.
