ORDER CANCELING CERTIFICATE

On April 1, 1999, the Staff of the Missouri Public Service Commission (Staff) filed a pleading asking the Commission to cancel the certificate of authority and accompanying tariff of Hi-Rim Communications, Inc. (Hi-Rim). The Commission granted Hi-Rim a certificate of service authority to provide intrastate interexchange telecommunications services in case number TA-95-311.

Staff states that Hi-Rim did not file an annual report in 1997 as required by Sections 392.210 and 392.390.1, RSMo. In addition, the 1998 annual report form sent to Hi-Rim by Staff was returned by the postal service as undeliverable. Staff also states that the Missouri Secretary of State's office administratively dissolved Hi-Rim on February 9, 1998, due to Hi-Rim's failure to file an annual report. Further, Staff states that the Internal Accounting Department received notification on May 18, 1998, that Hi-Rim filed for Chapter 11 bankruptcy effective June 13, 1997.

The Commission has reviewed the application and the official file and finds that the Certificate of Service Authority and Accompanying Tariff to Provide Intrastate Interexchange

Telecommunications Services granted to Hi-Rim in case number TA-95-311 shall be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of authority and tariffs granted in case number TA-95-311 to Hi-Rim Communications, Inc. shall be canceled on April 30, 1999, unless otherwise ordered by the Commission.
2. That this case may be closed on May 3, 1999.

1. DEFINITION OF TERMS

MISSOURI
Public Service Commission

For the purpose of this Tariff, the following definitions will apply:

Access Coordination

Provides for the design, ordering, installation, coordination, pre-service testing, service turn-up and maintenance on a Company or Customer provided Local Access Channel.

Administrative Change

A change in Customer billing address or contact name.

Alternate Access

Alternate Access is a form of Local Access except that the provider of the service is an entity, other than the Local Exchange Carrier, authorized or permitted to provide such Service. The charges for Alternate Access may be subject to private agreement rather than published or special tariff if permitted by applicable governmental rules.

Application for Service

A standard Company order form which includes all pertinent billing, technical and other descriptive information which will enable the Company to provide a communication Service as required.

ASR

ASR (Access Service Request) means an order placed with a Local Access Provider for Local Access.

Authorized User

A person, firm, corporation or other entity that either is authorized by the Customer to receive or send communications or is placed in a position by the Customer, either through acts or omissions, to send or receive communications.

Bandwidth

The total frequency band, in hertz, allocated for a channel.

Bill Date

The date on which billing information is compiled and sent to the Customer.

Call

A completed connection between the Calling and Called Stations.

Called Station

The telephone number called.

Calling Station

The telephone number from which a Call originates.

Cancellation of Order

A Customer initiated request to discontinue processing a Service order, either in part or in its entirety, prior to its completion. Cancellation charges will be assessed for each Circuit-end or Dedicated Access line canceled from an order prior to its completion by the Company, under the following circumstances: (1) if the LEC has confirmed in writing to the Company that the Circuit-end or Dedicated Access line will be installed; or (2) if the Company has already submitted facilities orders to and interconnecting telephone company.

Channel or Circuit

A dedicated communications path between two or more points having a Bandwidth or Transmission Speed specified in this Tariff and selected by a Customer.

Company Recognized National Holidays

The following are Company Recognized National Holidays determined at the location of the originator of the Call. The Company observes the following federally recognized holidays: New Year's Day, Martin Luther King Day, President's Day, Memorial Day, July 4th, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day and Christmas Day. The evening rate is used unless a lower rate would normally apply. When a Call begins in one rate period and ends in another, the rate in effect in each rate period applies to the portion of the Call occurring within that rate period. In the event that a minute is split between two rate periods, the rate in effect at the start of that minute applies.

Customer

The person, firm, corporation or governmental unit which orders Service and which is responsible for the payment of charges and for compliance with the Company's Tariff regulations. A Customer is considered to be an account for billing purposes. The term Customer also includes an entity that remains presubscribed to the Company Service after its account(s) are removed from the Company's billing system, subsequently continues to use Company's network, and is billed by a local exchange carrier for such use, or otherwise uses Service for which no other Customer is obligated to compensate Company.

Customer Premises/Customer's Premises

Locations designated by a Customer where Service is originated/terminated whether for its own communications needs or for the use of its resale customers.

Dedicated Access/Special Access

Dedicated Local Access between the Customer's Premises or serving wire center and the Company's Point-of-Presence for origination or termination of Calls.

DS-0

DS-0 means Digital Signal Level 0 Service and is a 64 Kbps signal.

When it becomes possible to determine specific terms and conditions for such offerings, they will be offered pursuant to such terms and conditions. Rates for services offered on an ICB will be structured to recover the Company's cost of providing the services. Terms of specific ICB contracts will be made available to the Commission upon request on a proprietary basis

2. RULES AND REGULATIONS

2.1. Description and Limitations of Services

2.1.1. Intrastate Telecommunications Service ("Service") is the furnishing of Company communication Services contained herein between specified locations under the terms of this Tariff.

2.1.2. Any member of the general public (including any natural person or legally organized entity such as a corporation, partnership, or governmental body) is entitled to obtain Service under this Tariff, provided that the Company reserves the right to deny Service: (A) to any Customer that, in the Company's reasonable opinion, presents an undue risk of nonpayment and refuses to comply with the deposit requirements set forth in Section 2.8.3, (B) in circumstances in which the Company has reason to believe that the use of the Service would violate the provisions of this Tariff or any applicable law or if any applicable law restricts or prohibits provision of the Service, or (C) if insufficient facilities are available to provide the Service (in such cases Company shall make best efforts to accommodate the needs of all potential Customers by means of facility improvements or purchases, of capacity, if such efforts will, in the Company's opinion, provide the Company with a reasonable return on its expenditures), but only for so long as such unavailability exists.

2.1.3. Company, when acting at the Customer's request and as its authorized agent, will make reasonable efforts to arrange for Service requirements, such as special routing, Diversity, Alternate Access, or circuit conditioning.

2.1.4. Service is offered in equal access exchanges subject to the availability of facilities and the provisions of this Tariff. Company reserves the right to refuse to provide Service to or from any location where the necessary facilities and/or equipment are not available.

2.1.5. Service may be discontinued after five business days written notice to the Customer if:

2.1.5.A. the Customer is using the Service in violation of this Tariff; or

2.1.5.B. the Customer is using the Service in violation of the law or Commission regulation.

2.1.6. Service begins on the date that billing becomes effective and is provided on the basis of a minimum period of at least one month, 24 hours per day. For the purposes of computing charges in this Tariff, a month is considered to have 30 days.

2.1.7. Service will be provided until canceled, by the Customer on not less than thirty (30) days' written notice from the date of postmark on the letter giving notice of cancellation.

2.1.8. The Company reserves the right to discontinue furnishing Services or billing options, upon written notice, when necessitated by conditions beyond its control. Conditions beyond the Company's control include, but are not limited to, a Customer's having Call volume or a calling pattern that results, or may result, in network blockage or other Service degradation which adversely affects Service to the calling party, the Customer, or other Customers of the Company.

2.1.9. 2.2 Other Terms and Conditions

2.2.2. The Customer agrees to operate the Company provided equipment in accordance with instructions of the Company or the Company's agent. Failure to do so will void the Company liability for interruption of Service and may make Customer responsible for damage to equipment pursuant to Section 2.2.3 below.

2.2.3. Customer agrees to return to the Company all Company-provided equipment delivered to Customer within five (5) days of termination of the Service in connection with which the equipment was used. 2.9. Assignment

- 2.9.1. 3. DESCRIPTION OF SERVICES

3.1. Wide Area ("WATS") and Message ("MTS") Toll Services

3.1.1. The Company offers WATS and MTS intrastate interexchange long distance service utilizing switched or dedicated access arrangements between the Customers Premises and the Company's facilities for call origination. Call termination is completed through a combination of Company facilities and LEC switched access arrangements. The Company does not have exclusion requirements, nor does the Company offer employee concessions, for any of the services provided hereunder.

3.2. 1+ Switched Outbound Service

3.2.1. Company's 1+ switched outbound services permit outward calling utilizing premium switched Feature Group D access on both the originating and terminating ends. The minimum call duration for billing purposes is six (6) seconds. Usage is measured thereafter in six (6) second increments and rounded to the next higher six (6) second period.

3.3. Dedicated Outbound Service

3.3.1. Dedicated outbound service permits outward 1+ calling to stations in diverse service areas. Dedicated outbound service is distinguished from other services by the existence of a dedicated, special access connection on one end. Customers with usage in excess of \$5,000.00 per month per DS-1 may elect Dedicated Access 1+ Service. The minimum call duration for billing purposes is six (6) seconds. Usage is measured thereafter in six (6) second increments and rounded to the next higher six (6) second period. Customer selecting this Service shall commit to utilize the Company's Service for a one year period, and shall agree to pay any applicable local loop charges.

3.4. 800 Switched Service

3.4.1. The Company's 800 Switched Inbound Service permits inward calling (via 800 codes) to a specific location utilizing premium switched, Feature Group D access on both ends. The Company's 800 Switched Service is available to Customers executing a month to month or long term contract with the Company. The minimum call duration for billing

3.5. Dedicated Inbound 800 Service

- 3.5.1. The Company's Dedicated Inbound 800 Service permits inward calling (via 800 codes) to specific location featuring the use of a dedicated, special access type connection on the terminating end. Dedicated 800 Service is available to Customers with usage charges in excess of \$5,000.00 monthly per DS-1, executing a one or two year term commitment agreement with the Company. The minimum call duration for billing purposes is six (6) seconds. Usage is measured thereafter in six (6) second increments and rounded to the next higher six (6) second period. In addition to the charges set forth below, the Customer is responsible for any applicable local loop charges.

3.6. Calling Card Service

- 3.6.1. The Company's Calling Card Service is a customized calling card service with features including voice response or touch-tone dialing. The charges for Calling Card Service are calculated on the basis of each completed call. The minimum call duration for billing purposes is six (6) seconds. Usage is measured thereafter in six (6) second increments and rounded to the next higher six (6) second period.

3.7. Timing of Calls

- 3.7.1. Long distance usage charges are based on the actual usage of the service. Chargeable time begins when a connection is established between the Calling Station and the Called Station. Chargeable time ends when either party "hangs up" thereby releasing the network connection.
