ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS

Issue Date: October 13, 2005

Effective Date: October 23, 2005

On September 27, 2005, the Staff of the Commission filed a Motion to Open Case and Cancel Certificates of Service Authority and Associated Tariffs. Staff requested that the Commission cancel the interexchange certificates of service authority and accompanying tariffs of Atlas Mobilfone, Inc.; Celebrate Communications L.L.C.; and Citylink of Kansas City. Staff also requested that the Commission cancel the interexchange certificate of service authority and accompanying tariff, as well as the basic local exchange certificate of service authority, of Steve's Wildcat Web, Inc.

Staff stated that these companies are no longer entitled to their certificates and tariffs because each company marked on its 2004 Statement of Revenue form that it no longer wishes to have a certificate. Furthermore, Staff alleges that each company: is current on its annual report and owes no assessments; has no actions pending before the Commission; has no Missouri operations; and are in "good" or "active" standing with the Missouri of Secretary of State.

Commission Rule 4 CSR 240-2.080(15) gives parties 10 days to respond to pleadings. Each company failed to respond within 10 days.

Section 392.410, RSMo 2000, gives the Commission authority over granting certificates of service authority to provide telecommunications services. The Commission has reviewed Staff's motion, and finds that it should cancel the certificates of service authority and accompanying tariffs that Staff requested the Commission to cancel.

IT IS THEREFORE ORDERED:

1. That the Staff of the Commission's Motion to Open Case and Cancel Certificates of Service Authority and Accompanying Tariffs is granted.
2. That the interexchange certificate of service authority granted to Atlas Mobilfone, Inc., in Case No. TA-2000-723, and accompanying tariff, MO P.S.C. Tariff No. 1, are canceled.
3. That the interexchange certificate of service authority granted to Celebrate Communications L.L.C, in Case No. TA-98-529, and accompanying tariff, P.S.C. Mo. No. 1, are canceled.
4. That the interexchange certificate of service authority granted to Citylink of Kansas City in Case No. TA-2000-378, and accompanying tariff, Missouri P.S.C. Tariff No. 1, are canceled.
5. That the interexchange certificate of service authority granted to Steve's Wildcat Web, Inc., in Case No. XA-2005-0021, and accompanying tariff, P.S.C. MO No. 1, and the basic local exchange certificate of service authority granted to Steve's Wildcat Web, Inc., in Case No. CA-2004-0568, are canceled.
6. That this order shall become effective on October 23, 2005.

7. That this case may be closed on October 24, 2005.
