## ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: April 28, 2023 Effective Date: May 28, 2023

On March 1, 2023, Corcom Communications, Inc. notified the Commission that it wished to voluntarily relinquish its certificate of service authority to provide non-switched local exchange and interexchange services in the State of Missouri. The Commission granted Corcom Communications a certificate of service authority effective August 7, 2015, in File Number TA-2015-0342. Corcom Communications also has an applicable tariff, Tracking Number JX-2018-0119.

On March 2, 2023, the Commission established a time to intervene to Corcom Communications' filing, and directed Staff to respond. On April 12, 2023, Staff filed its response recommending the Commission cancel Corcom Communications' certificate of service authority as Corcom Communications requested. On April 25, 2023, Staff filed to amend its motion to include recommending the Commission also cancel the tariff of Corcom Communications.

No objections or requests for a hearing were filed. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Corcom Communications' request and Staff's response, the Commission finds that the certificate of service authority granted to Corcom Communications shall be canceled.

#### THE COMMISSION ORDERS THAT:

- The certificate of authority to provide non-switched local exchange and interexchange services granted to Corcom Communications, in File No. TA-2015-0342, is canceled.
- 2. Corcom Communications' tariff assigned Tracking No. JX-2018-0119 is canceled.
  - 3. This order shall become effective on May 28, 2023.
  - 4. This file shall be closed on May 29, 2023.
