ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: January 30, 2015

Effective Date: February 1, 2015

On March 11, 2014, Central Rivers Wastewater Utility, Inc. ("Central Rivers") submitted a request for a small sewer utility rate increase. On January 7, 2015, the Commission issued an order approving the stipulation and agreement filed by Central Rivers, the Staff of the Commission, and the Office of the Public Counsel ("OPC"). In that order, the Commission directed Central Rivers to file a tariff reflecting the terms of the agreement. On January 19, Central Rivers filed a compliance tariff sheet (Tracking No. YS-2015-0246) designed to produce the agreed upon revenue increase.

On January 20, Central Rivers filed a *Motion for Expedited Treatment*, requesting the proposed tariff sheet to go into effect on February 1, rather than February 18. Central Rivers states that an effective date at the beginning of the month will allow the company to transition to the new rate without the need for pro-rating its bills.

On January 20, the Commission issued an order setting a January 29 deadline for objections to Central Rivers' compliance tariff or the request for expedited treatment. Staff filed a response indicating it examined the proposed tariff and determined it complies with the stipulation and agreement and the Commission's order. Staff also

states it has no objections to the request for expedited treatment. No objections to Central Rivers' compliance tariff or its request for expedited treatment were received.

Upon reviewing the pleadings, the Commission finds Central Rivers tariff sheet complies with the Commission's January 7 order and will approve it. Furthermore, the Commission finds good cause exists for the tariff to become effective in less than thirty days. For this reason, the Commission will approve the tariff becoming effective on February 1, 2015.

THE COMMISSION ORDERS THAT:

1. The following tariff filed on January 19, 2015, by Central Rivers Wastewater Utility, Inc., and assigned Tracking No. YS-2015-0246, is approved to become effective on February 1, 2015:
