ORDER CANCELING CERTIFICATES
AND ACCOMPANYING TARIFFS

Issue Date: May 19, 2008

Effective Date: May 29, 2008

On April 8, 2008, the counsel for Network PTS, Inc. (NPTS) filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariffs of NPTS to provide basic local exchange telecommunications services in Missouri.

In Case Number CA-2007-0147, the Commission granted NPTS a certificate of service authority to provide basic local exchange telecommunications services. NPTS' tariffs, P.S.C. MO Tariff No. 2 and P.S.C. MO Tariff No. 3, were also approved.

On April 28, 2008, Staff filed its Motion to Cancel Certificate of Service Authority. Staff's motion states that NPTS is no longer providing service in Missouri and has no past assessments or annual reports due to the Commission. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariffs.

On April 29, 2008, NPTS filed an Amended Application to Cancel Certificates of Service Authority and Accompanying Tariffs. In its amended application NPTS asked the Commission to also cancel the certificate of service authority and accompanying tariff to provide competitive interexchange telecommunications services in Missouri.

In Case Number XA-2005-0115, the Commission granted NPTS a certificate of service authority to provide competitive interexchange telecommunications services. NPTS' tariff, P.S.C. MO Tariff No. 1, was also approved.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on NPTS' applications, Staff's motion, and the fact that NPTS has no Missouri customers, the Commission finds that the certificates of service authority and accompanying tariffs granted to Network PTS, Inc. shall be canceled.

IT IS ORDERED THAT:

1. The certificate of service authority to provide competitive interexchange telecommunications services in Missouri, granted to Network PTS, Inc. in Case Number XA-2005-0115, is canceled.
2. The certificate of service authority to provide basic local exchange telecommunications services in Missouri, granted to Network PTS, Inc. in Case Number CA-2007-0147, is canceled.
3. Network PTS, Inc.'s tariff, Mo. P.S.C. No. 1, is canceled
4. Network PTS, Inc.'s tariff, Mo. P.S.C. No. 2, is canceled.

5. Network PTS, Inc.'s tariff, Mo. P.S.C. No. 3, is canceled.
6. This order shall become effective on May 29, 2008.
7. This case may be closed on May 30, 2008.
