4.5 Customer Deposits and Advance Payments

4.5.1 Advance Payments

To safeguard its interests, the Company may require a Customer to make an Advance Payment before services and facilities are furnished. The Advance Payment will not exceed an amount up to two months of estimated monthly usage charges. In addition, where special construction is involved, the Advance Payment may also include an amount equal to the estimated non-recurring charges for the special construction and recurring charges (if any) for a period to be set between the Company and the Customer. The Advance Payment will be credited to the Customer's initial bill. An advance payment may be required in addition to a deposit.

4.5.2 Deposits

To safeguard its interests, the Company may require a Customer to make an Advance Payment before services and facilities are furnished. The Advance Payment will not exceed an amount up to two months of estimated monthly usage charges. 

Specialized rates or charges will be made available to similarly situated Customers on a non-discriminatory basis. To be eligible for an SPA, a Customer (i) must not be in breach of any AFS agreement or obligation, nor (ii) have any outstanding past due balances on charges owed to AFS under such agreement or obligation.
- 5.4.2 In addition to any rate or charge established by Company, the Customer shall pay any applicable taxes, surcharges (including without limitation Universal Service Fund charges or other charges prescribed by governmental authorities), access charges, any recurring or nonrecurring charges imposed by local exchange telephone companies or interexchange carriers incurred by or on behalf of the Customer in establishing and maintaining service. Such charges may be billed by Company or directly by the local exchange company or interexchange carrier, at Company's option.
