## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

)

Issue Date: August 31, 2009 Effective Date: September 10, 2009

On August 3, 2009, the Staff of the Missouri Public Service Commission filed a motion requesting Camarato Distributing, Inc.'s ("Camarato") certificate of service authority and accompanying tariff be cancelled. The Commission granted Camarato a certificate of service authority to provide basic local exchange and interexchange telecommunication service in the State of Missouri.

In File Number TA-99-152, the Commission granted Camarato a certificate to provide basic local exchange and interexchange telecommunication service. Camarato's tariff, PSC MO No. 1, was also approved.

Staff stated in its Motion that the Missouri Secretary of State administratively dissolved Camarato on December 2, 2004 for failure to file an annual report. Staff stated that Camarato has failed to file 2007 and 2008 annual reports and owes the Commission a total of \$37.82 in assessments for 2009 and 2010. Staff indicated that to the best of their knowledge, information and belief, Camarato is no longer

providing telecommunication services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff.

On August 5, 2009, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than August 17, 2009. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's request and because Camarato is not providing telecommunications service in Missouri, the Commission finds that the certificate of service authority and tariffs granted to Camarato Distributing, Inc., shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide basic local exchange and interexchange telecommunications services granted to Camarato Distributing, Inc., in File Number TA-99-152, is canceled.

2. Camarato Distributing, Inc.'s tariff, PSC MO No. 1, is canceled.

3. This order shall become effective on September 10, 2009.



Β. <u>Sheet Revision Numbers</u> – Revision numbers also appear in the upper-right corner of the sheet. These numbers are used to determine the most current sheet version on file with the Commission. For example, the 4th revised Sheet 14 cancels the third revised Sheet 14. Because of various suspension periods, deferrals, etc. the Commission follows in their Tariff approval process, the most current sheet number on file with the Commission is not always the Tariff page in effect. Consult the Check Sheet for the sheet currently in effect.

C. Paragraph Numbering Sequence – There are nine levels of paragraph coding. Each level of coding is subservient to its next higher level of coding.

#### SECTION 1 – DEFINITIONS

Certain terms used generally throughout this tariff are defined below.

Account Number: Customer's telephone number is his/her account number.

<u>Authorized User</u>: A person that either is authorized by the Customer to use local exchange telephone service at Customer's residence or other location, or is placed in a position by the Customer, either through acts or omissions, to use local exchange telephone service.

<u>Basic Local Service</u>: Two-way switched voice service within a local calling scope as determined by the commission. Basic Local Service does not include: long distance, collect calls, operatorassisted calls, third number billed calls, or any service that may be billed to Customer's telephone number.

<u>Call Forwarding</u>: Permits calls directed to a Customer's line to be routed to a user-defined line inside or outside the Customer's telephone system.

Company: Camarato Distributing, Inc. which is the issuer of this tariff.

<u>Conference/Three-Way</u>: The User can sequentially call up to two other people and add them together to make a three-way call.

<u>Customer</u>: The person, firm, corporation or entity which orders service, uses and/or is responsible for the payment of charges and for compliance with the Company's tariff regulations.

<u>Customer Service Agreement</u>: The written request for local exchange services executed by the Customer and the Company in a format specified by the company. The signing of a Service Order by the Customer and acceptance thereof by the Company initiates the respective obligations of the parties as set forth therein and pursuant to this tariff, but the duration of the service is calculated from the Service Commencement Date.

Exchange Carrier: Any individual, partnership, association, joint-stock company, trust, governmental entity or corporation engaged in the provision of local exchange telephone service.

Incumbent Local Exchange Carrier (ILEC): Local exchange carriers that are providing telephone exchange service in an area on the date of the enactment of the Telecommunications Act of 1996 and that are deemed to by members of the exchange carrier association.

Activation Fee: The non-recurring charge to Customer for initiating service.

#### SECTION 1 - DEFINITIONS (continued)

LATA: A local access and transport area established pursuant to the Modification of Final Judgment entered by the United States District Court for the District of Columbia in Civil. Action No. 82-0192 for the provision and administration of communications services.

Local Calling: A completed call or telephone communication between a calling Station and any other Station within the local service area of the calling Station.

Local Calling Area: The area within which telecommunications service is furnished to customers. A local calling area may include one or more exchange service areas or portions of exchange service areas. Additionally, a local calling area includes any mandatory extended area exchanges.

Local Exchange Carrier: A company which furnishes exchange telephone service.

<u>Non-Recurring Charges</u>: The one-time initial charges for services or facilities, including but not limited to, charges for processing and installation, for which the Customer becomes liable at the time the Service Order is executed.

<u>Recurring Charges</u>: The monthly charges to the Customer for services, facilities and equipment, which continue for the agreed upon duration of the service.

<u>Service Commencement Date</u>: The first day following the date on which the Company notifies the Customer that the requested service or facility is available for use, unless extended by the Customer's refusal to accept service which does not conform to standards set forth in the Service Order or this tariff, in which case the Service Commencement Date is the date of the Customer's acceptance of service. The parties may mutually agree on a substitute Service Commencement Date.

<u>Services</u>: The Company's local telecommunications services offered to the Customer. Such services consist of basic and optional elements.

<u>Speed Dial</u>: Provides a User with the option to call selected directory numbers by dialing a one or two-digit code.

Station: Telephone equipment from or to which calls are placed.

<u>Trunk</u>: A communications path connecting two switching systems in a network, used in the establishment of an end-to-end connection.

<u>User</u>: A Customer or any other person authorized by the Customer to use Services provided under this tariff.

#### SECTION 2 – REGULATIONS

#### 2.1 <u>Undertaking of the Company</u>

#### 2.1.1 <u>Scope</u>

The Company undertakes to furnish intrastate telecommunications services within the State of Missouri under the terms of this tariff as a reseller. Service is available 24 hours a day, seven days a week.

- 2.1.2 Shortage of Equipment or Facilities
  - A. The Company reserves the right to limit or allocate the use of existing facilities, or of additional facilities offered by the Company when necessary because of lack of facilities or due to some other cause beyond the Company's control.
  - B. The furnishing of service under this tariff is subject to availability on a continuing basis of all necessary facilities from the ILEC or other providers to the Company for resale.

#### 2.1.3 Terms and Conditions

- A. Service is provided on a calendar month basis, commencing on the date that the incumbent carrier determines to be the date of service order completion. Eight (8) calendar days from commencement of service, and on the same date monthly thereafter, the customer will be mailed, via First Class-U.S. Mail, a renewal of service notice.
- B. Renewal prepayment for service is due at the address stipulated therein, on or before 3:00 PM on the monthly calendar date anniversary that service commenced. Fifteen (15) calendar days from commencement of service, and on the same date monthly thereafter, the customer will be mailed, via First Class-U.S. Mail a renewal notice reminder, containing a notice of pending disconnection of service.
- C. If CDI has not received renewal payment by the designated due date, service shall be suspended the day following the due date. In the event service is suspended under these conditions, a reconnection fee shall apply as set forth in 4.6. RECONNECTION OF BLOCKED OR SUSPENDED SERVICE of this tariff.

- D. If a prepayment for service and reconnection fee is not received within a ten (10) calendar day suspension period, service shall be permanently disconnected. Once service has been disconnected, an activation fee and prepayment of service shall be required to provide service.
- E. When prepayment for service is received on or before the due date, service shall continue in an uninterrupted manner.
- F. At the expiration of any term specified in a Customer Service Agreement, or in any extension thereof, service shall continue on a month to month basis at the then current rates unless terminated by either party upon five (5) days written notice. Any termination shall not relieve Customer of its obligation to pay any charges incurred under the Agreement and this tariff prior to termination. The rights and obligations which by their nature extend beyond the termination of the term of the Agreement shall survive such termination.
- G. This tariff shall be interpreted and governed by the laws of the State of Missouri.
- H. The Customer has no property right to the telephone number or any other call number designation associated with services furnished by the Company. The Company reserves the right to change such numbers, or the central office designation associated with such numbers, or both, assigned to the Customer, whenever the Company deems it necessary to do so in the conduct of its business.
- 2.1.4 Liability of the Company
  - A. The liability of the Company for damages arising out of the furnishing of its services, including but not limited to mistakes, omissions, interruptions, delays, or errors, other defects, or representations by the Company, or use of these services or damages arising out of the failure to furnish the service whether caused by acts or omission, shall be limited to the extension of allowances for interruptions as set forth in Section 2.6 below. The extension of such allowances for interruption shall be the sole remedy of the Customer and the sole liability of the Company. The Company will not be liable for any direct, indirect, incidental, special, consequential, exemplary or punitive damages to Customer as a result of any Company service, equipment or facilities, or the acts or omissions or negligence of the Company's employees or agents.

With respect to any other claim or suit, by a Customer or by others, for damages associated with the ordering (including the reservation of any specific number for use with a service), installation (including delays thereof), provision, termination, maintenance, repair, interruption or restoration of any service or facilities offered under this tariff, and subject to the provisions of Section 2.6, the Company's liability, if any, shall be limited as provided herein.
- C. The Company shall not be liable for any delay or failure of performance or equipment due to causes beyond its control, including but not limited to: acts of God, fire, flood, explosion or other catastrophes; and law, order, regulation, direction, action or request of the United States government or of any other government, including state and local governments having or claiming jurisdiction over the Company, or of any department, agency, commission, bureau, corporation or other instrumentality of any one or more of these federal, state, or local governments, or of any military authority; preemption of existing service in compliance with national emergencies; insurrections; riots; wars; unavailability of rights-of-way or materials, or strikes, lockouts, work stoppages, or other labor difficulties.
- D. The Company shall not be liable for: (a) any act or omission of any entity furnishing the Company or the Company's Customers facilities or equipment used for or with the services the Company offers; or (b) for the acts or omissions of other common carriers of local exchange companies.
- E. The Company shall not be liable for any damages or losses due to the fault or negligence of, or any omission by the Customer or due to the failure or malfunction of Customer-provided equipment or facilities.
- F. The Customer shall indemnify and hold the Company harmless from any and all loss, claims, demands, suits or other action, or any liability whatsoever, whether suffered, made, instituted, or asserted by any other party or person(s), and for any loss, damage, or destruction of any property, whether owned by the Customer or others, caused or claimed to have been caused directly or indirectly by the installation, operation, failure to operate, maintenance, removal, condition, location or use of any installation provided by the Company. The Company reserves the right to require each Customer to sign an agreement acknowledging acceptance of the provisions of this section as a condition precedent to such installations.



- G. Claims for defamation, libel, slander, invasion of privacy, infringement of copyright, unauthorized use of trademark, trade name, or service mark, unfair competition; interference with or misappropriation, or violation of any contract, proprietary or creative right, or any other injury to any proprietary or creative right, or any other injury to any person, property, or entity arising from the material, data, information, or content, revealed to, transmitted, processed, handled, or used by the Company under this tariff;
  - 2. Patent infringement claims arising from combining or connecting the service offered by the Company with apparatus and systems of the Customer or others; and
  - 3. All other claims arising out of any act or omission of the Customer or others, in connection with any service provided by the Company pursuant to this tariff.
- I. The entire liability of the Company for any claim, loss, damage or expense from any cause whatsoever shall in no event exceed sums actually paid to the Company by the Customer for the specific services giving rise to the claim, and no action or proceeding against the Company shall be commenced more than one year after the service is rendered, unless more time is allowed pursuant to Missouri law.
- J. THE COMPANY MAKES NO WARRANTIES OR REPRESENTATION, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR USE, EXCEPT THOSE EXPRESSLY SET FORTH HEREIN.

- K. The Company shall not be liable for any act or omission of any other company or companies furnishing a portion of the service, or for damages associated with service, channels or equipment which it does not furnish, or for damages which result from the operation of Customer-provided systems, equipment, facilities or services which are interconnected with Company services.
- L. No agent or employee of any other carrier shall be deemed to be an agent or employee of the Company.
- M. With respect to Emergency Number 911 Service:
  - 1. This service is offered as an aid in handling assistance calls in connection with fire, police and other emergencies.
  - 2. The company is obligated to supply the E-911 service provider in the Company's service area (the "E-911 Service Provider) with information necessary to update the E-911 database at the time the Company submits customer orders to the local exchange company whose service is being resold pursuant to this tariff.
  - 3. If, and when, the company provides local basic service to a customer by means of the Company's own cable pair, or over any other exclusively owned facility, the Company will be obligated to make the necessary equipment or facility additions in the 911 Service Provider's equipment in order to properly update the database for 911. The Company will be obligated to provide facilities to route calls from the end users to the proper PSAP. The Company recognizes the authority of the E-911 customer to establish service specifications and grant final approval or denial of service configurations offered by the Company.
  - 4. The Company will collect 911 surcharges and remit all surcharge revenue to the appropriate governmental entity pursuant to section 190.310 RSMo., or any amendments thereto.







#### 2.6 Allowances for Interruptions of Service

## **RECTD** AUG 1 6 1999

When the use of service or facilities furnished by the Company is interrupted due to any cause other than the negligence or willful act of the Customer, or the operation or failure of the facilities or equipment provided by the Customer, a pro rata adjustment of the monthly Charges subject to interruption will be allowed for the service and facilities rendered useless and inoperative by reason of the interruption whenever said interruption continues for a period of 24 hours or more from the time the interruption is reported to or known to exist by the Company, except as otherwise specified in the Company's tariff.

It shall be the obligation of the Customer to notify Company immediately of any interruption in service for which a credit allowance is desired by Customer. Before giving such notice, the Customer shall ascertain that the trouble is not being caused by any action or omission of the Customer within his or her control, or is not in wiring or equipment, if any, furnished by Customer and connected to Company's terminal. If the Customer reports a service, facility or circuit to be inoperative but declines to release it for testing and repair, it is considered to be impaired, but not interrupted.

#### 2.6.1 Credit Allowances

- A. Credit for failure of service or equipment will be allowed only when failure is caused by or occurs in facilities or equipment owned, provided and billed for, by Company.
- B. Credit allowances for failure of service or equipment starts when Customer notifies Company of the failure or when Company becomes aware of the failure and ceases when the operation has been made to notify Customer.
- C. For calculating credit allowances, every month is considered to have thirty (30) days. A credit allowance is applied on a pro rata basis against the monthly Charges specified hereunder and is dependent upon the length of the interruption. Only those facilities on the interrupted portion of the circuit will receive a credit. Credit allowances for services outages that exceed 24 hours in duration will be rounded up to the next whole 24 hours.





#### 4.1 Prepaid Local Exchange Service

The Company's Local Telephone Service enables the Customer to:

- Place or receive calls to any calling Station in the local calling area as defined herein;



This feature enables the Customer to view on a display unit the Calling Party Directory Name and/or Number (CPN) on incoming telephone calls.

When Caller ID is activated on a Customer's line, the CPN of incoming calls are displayed on the called CPE during the first long silent interval of the ringing cycle.

Per line blocking for the blocking of CPN will be available upon request at no charge to the following entities for lines over which the official business of the agency is conducted, including those at the residences of employees/volunteers, where an executive officer of the agency registers a need for blocking and provides the required certification to the Company: (1) private, nonprofit, tax exempt, domestic violence intervention agencies and (b) federal, state and local law enforcement agencies. The CPN will not be transmitted from a line equipped with this capability. Instead, Calling Line Identification Customers will receive an anonymous indicator. This anonymous indicator notifies the Caller ID Customer that the calling party has elected to block the delivery of their name and telephone number. The blocking of CPN will not be provided on calls originating from the Customer-Owned Pay Telephone Service.

Any Customer subscribing to Caller ID will be responsible for the provision of a display device which will be located on the Customer's premises. The installation, repair and technical capability of that equipment to function in conjunction with the feature specified herein will be the responsibility of the Customer. The Company assumes no liability and will be held harmless for any incompatibility of this equipment to perform satisfactorily with the network features described herein.

Telephone CPN information transmitted via Caller ID is intended solely for the use of the Caller ID subscriber. Resale of this information is prohibited by this tariff. CPN will not be displayed if the called party is off-hook or if the called party answers during the first ring interval. CPN will by displayed for calls made from another central office only if it is linked by appropriate facilities. Caller ID is not available on operator handled calls as such calls are originated from outside of Camarato Distributing, Inc.'s system.

#### 4.1.7 Call Trace

Customers receiving annoying or anonymous calls may request (1) a telephone number change, which will be provided at no charge by Camarato Distributing, Inc., or (2) the capability to utilize Call Trace on a per activation basis, as needed. Call Trace allows the customer to dial a code (\*57) to automatically request that the following information be recorded.

The date and time Call Trace was activated.

A service that allows the end user to reject certain unwanted calls. The end user is allowed to specify six pre-selected numbers to be blocked. Call blocker utilizes ANI in determining which phone calls to block.





#### 4.4 <u>Directory Listings</u>



#### 4.5 <u>Emergency Services (Enhanced 911)</u>

Allows Customers to reach appropriate emergency services including bonc, fire and medical services. Enhanced 911 has the ability to selectively route an emergency call to the primary E911 provider so that it reaches the correct emergency service located closest to the caller. #### 4.6 <u>Promotional Offerings</u>

This information is provided in accordance with the rules of the Missouri Public Service Commission and explains your rights and responsibilities as a residential telephone Customer.

#### Your Telephone Bill

You will receive a telephone bill from us each month. Camarato Distributing, Inc. provides only basic local telephone service (including access to 911 and toll-free 800 services) and the custom calling services listed below. Long distance service is not provided by Camarato Distributing, Inc. Additionally, you will not have access to the following calls, which will be blocked by Camarato Distributing, Inc.: long distance, toll, third-number billed calls, incoming collect calls and local and long distance directory assistance. Camarato Distributing, Inc. does not require a deposit for service.

A one-time initiation fee and the first month's service charge, plus associated taxes are required to initiate service. The initiation fee is 100% refundable upon request for termination of service within ten (10) business days following the date upon which the Statement of Rights and Responsibilities is either hand-delivered or mailed to the Customer. In the situation where the Statement of Rights and Responsibilities is mailed to the Customer, the ten (10) business days shall start on the date of the postmark. The recurring monthly service charge, plus associated taxes, shall be prorated for the actual number of days which service has been provided with the non-used portion being refunded to the Customer.



Disconnection or Suspension of Telephone Service

Your telephone service is subject to disconnection or suspension for any of the reasons listed below. If service is disconnected, a new telephone number will be assigned and you will be required to pay initiation charges again. If service is suspended, your telephone number is reserved for ten (10) days and you will not be charged initiation charges again, however a reconnection charge shall apply as per this tariff.

- 1. Nonpayment of any undisputed delinquent charge;
- 2. Unauthorized use of telephone utility equipment in a manner which creates an unsafe condition or creates the possibility of damage or destruction to such equipment;
- 3. Failure to substantially comply with terms of a settlement agreement;
- 4. Refusal after reasonable notice to permit inspection, maintenance or replacement of telephone utility equipment;
- 5. Material misrepresentation of identity in obtaining telephone utility service; and as provided by state or federal law.

The Company will postpone a discontinuance for a time not in excess of twenty-one (21) days If the telephone is necessary to obtain emergency medical assistance for a person who is a member of the household where the telephone service is provided and where such person is under the care of a physician. Any person who alleges such emergency, if requested, shall provide the Company with reasonable evidence of such necessity.

#### Reconnection of Service


