ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS

Issue Date: April 28, 2009 Effective Date: May 8, 2009

On April 9, 2009, the Staff of the Commission filed a motion asking the Commission to cancel the certificates of service authority and the accompanying tariffs of Telcentrex, LLC ("Telcentrex"), a company that has been authorized to offer interexchange and basic local exchange telecommunication services by the Commission.

In File Number XA-2007-0252, the Commission granted Telcentrex a certificate of service authority to provide interexchange telecommunications services. The Commission also approved the company's tariff, P.S.C. Mo. No. 1.

In File Number CA-2007-0251, the Commission granted Telcentrex a certificate of service authority to provide basic local exchange telecommunications services throughout all exchanges currently served by Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri; Embarq Missouri, Inc. d/b/a Embarq; CenturyTel of Missouri, LLC; and Spectra Communications Group,

LLC d/b/a CenturyTel. The Commission also approved the company's tariff, P.S.C. Mo. No. 2.

Staff's motion states that on May 27, 2008, the Office of General Counsel of the Missouri Public Service Commission attempted to contact the Company to inform them of the Company's failure to file a 2007 annual report. The letter was returned for lack of a forwarding address. On August 6, 2008, Staff obtained a current address for Telcentrex and forwarded the May 27, 2008 letter. The Company requested the Commission cancel their certificates and accompanying tariffs. Telcentrex indicated they had never done business in the state of Missouri, nor has any intention of conducting future business in Missouri.

Staff recommends that the Commission cancel the company's certificates of service authority and accompanying tariffs, P.S.C. Mo. No. 1 and 2, to provide interexchange and basic local exchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion to cancel the certificates and tariffs, the Commission finds that the certificates of service authority and accompanying tariffs granted to Telcentrex, LLC, shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide intrastate interexchange telecommunications services granted to Telcentrex, LLC, in File Number XA-2007-0252, is canceled.
- 2. Telcentrex, LLC's tariff, P.S.C. Mo. Tariff No. 1, granted in File No. XA-2007-0252, is canceled.
- 3. The certificate of authority to provide basic local exchange telecommunications services granted to Telcentrex, LLC, in File Number CA-2007-0251, is canceled.
- 4. Telcentrex, LLC's tariff, P.S.C. Mo. Tariff No. 2, granted in File No. CA-2007-0251, is canceled.
 - 5. This order shall become effective on May 8, 2009.
 - 6. This file may be closed on May 9, 2009.
