ORDER CANCELLING CERTIFICATE AND TARIFF AND CLOSING CASE

Issue Date: August 2, 2005 Effective Date: August 12, 2005

This order cancels the certificate of service authority and tariffs of Bee Line Long Distance, doing business as Hello Telecom.

On July 19, 2005, the Staff of the Missouri Public Service Commission moved to cancel the certificate of service authority and tariffs of Bee Line Lomg Distance, doing business as Hello Telecom. In support thereof, Staff states that this Commission granted Bee Line, a Utah limited liability company, a certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services in March 2003, in Case No. XA-2003-0262. In the same case, the Commission approved Bee Line's tariff, Missouri P.S.C. Tariff No. 1.

Staff further states that the web site of the Office of the Missouri Secretary of State reports that the certificate of authority granted to Bee Line was revoked on January 11, 2005. Section 351.602.3, RSMo 2000, states that "[t]he authority of a foreign corporation to transact business in this state ceases on the date shown on the certificate revoking its certificate of authority." Staff also states that Bee Line's mail has been returned by the post office as undeliverable. The mail had been sent to the address provided to the

Commission by the company. Staff states that Elmo Beutler, a manager of Bee Line, contacted the Commission's Data Center on July 12, 2005, and requested that Bee Line's certificate and tariff be cancelled because Bee Line is no longer operating in Missouri. Staff states that Bee Line does not owe any Commission assessments.

Staff urges the Commission to cancel Bee Line's certificate and tariffs because it has ceased operations in Missouri.

The Commission finds that Bee Line has ceased operations in Missouri and has informally requested that its certificate and tariffs be cancelled. For these reasons, the Commission finds that Bee Line's certificate and tariff should be cancelled.

IT IS THEREFORE ORDERED:

- That the Motion to Open Case and Cancel Certificate of Service Authority and Tariffs, filed on July 19, 2005, by the Staff of the Missouri Public Service Commission, is granted.
- 2. That the certificate of service authority granted to Bee Line Long Distance, doing business as Hello Telecom, in March 2003, in Case No. XA-2003-0262, is cancelled.
- 3. That the tariff of Bee Line Long Distance, doing business as Hello Telecom, approved in March 2003, in Case No. XA-2003-0262, is cancelled.

- 4. That this order shall become effective on August 12, 2005.
- 5. That this case may be closed on August 13, 2005.
