## ORDER CANCELING SERVICE AUTHORITY

Issue Date: September 16, 2022 Effective Date: October 17, 2022 On August 10, 2022, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange telecommunications service authority and applicable tariff of Network Service Billing, Inc. (Company). On August 11, 2022, Staff filed a corrected motion.

On June 29, 2005, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in Case No. XA-2005-0421. The Company also has an applicable tariff, Tracking No. YX-2005-0991. Staff's motion states that the Company wishes to cancel the certificate and applicable tariff. The Company states that it no longer offers telecommunications services in Missouri and that no customers will be affected.

On August 15, 2022, the Commission issued its order that anyone wishing to respond to Staff's motion or request a hearing do so by filing a pleading no later than August 25, 2022. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission may cancel the certificate and applicable tariff based on Staff's motion.
