APPLICATION FOR CANCELLATION OF TARIFF

COMES NOW Citizens Electric Corporation ("Citizens") by and through its attorneys, Andereck, Evans, Milne, Peace & Johnson, by Victor S. Scott and Lisa Chase, pursuant to Rule 4 CSR 240-2.060, and Section 393.110.2, RSMo., as amended by Senate Bill No. 255 effective August 28, 2003, and for its Application for Cancellation of its Tariff, P.S.C. Mo. Nos. 2 and 7, Citizens states as follows:

1. Citizens Electric Corporation (Citizens) is a Missouri not-for-profit electric corporation doing business in Southeast Missouri in the Counties of Ste. Genevieve, Perry, North Cape Girardeau and Eastern St. Francois. Its principle place of business is 150 Merchant Street, Ste. Genevieve, Missouri 63670. A copy of Citizens' Articles of Incorporation were filed with the Commission in Case No. EF-2001-476 and are incorporated herein by reference. A copy of Citizens' Certificate of Good Standing is **attached hereto as Exhibit 1.**

3. Citizens operates on a not-for-profit cooperative business plan pursuant to its bylaws and provides electric service to over 24,980 consumers who are also member-owners of the Corporation. The majority of Citizens' consumer-owners reside in Ste. Genevieve and Perry Counties, both of which are counties of the third classification. As successor to Genevieve Electric Cooperative, Citizens was granted a certificate of public convenience and necessity by the Commission to serve these consumers..

4. On August 28, 2003, Senate Bill No. 255 went into effect which amends Section 393.110 of the Revised Statutes of Missouri. Section 393.110.2., as amended, provides that:

...the public service commission shall not have jurisdiction over the rates, financing, accounting, or management of any electrical corporation which is required by its bylaws to operate on the not-for-profit cooperative business plan, with its consumers who receive service as the stockholders of such corporation, and which holds a certificate of public convenience and necessity to serve a majority of its consumer-owners in counties of the third classification as of August 28, 2003....

5. This amendment effectively limits Missouri Public Service Commission's jurisdiction of Citizens in that it will no longer regulate Citizens' rates, financing,

accounting, or management but will continue to regulate the safety and reliability of Citizens' operations.

6. In response to the passage of Senate Bill No. 255 and the amendment to Section 393.110 RSMo. now in effect, Citizens herein respectfully requests that its Tariffs, P.S.C. Mo. Nos. 2 and 7, be cancelled.

7. Citizens further states that cancellation of its tariffs should have no effect on Citizens' Certificates of Public Convenience and Necessity as previously granted by the Commission.

8. Citizens also states herein that it has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three years of the date of this application, nor does Citizens have any annual report or assessment fees that are overdue.

WHEREFORE, for the foregoing reasons, Citizens Electric Corporation hereby requests the Commission to issue an order canceling its Tariffs, P.S.C. Mo. Nos. 2 and 7, and acknowledging that Citizens' certificates of convenience and necessity remain in effect.


