## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 30, 2011

Effective Date: October 10, 2011

On September 13, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Accutel of Texas, Inc. ("Accutel") certificate of service authority and accompanying tariff to provide interexchange and basic local exchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-2000-410, the Commission granted Accutel a certificate of service authority to provide interexchange and basic local exchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Accutel communicated with Staff that the company is no longer providing service in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange and basic local exchange telecommunications services, and the company's accompanying tariff.

On September 16, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than September 26, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Accutel of Texas, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide interexchange and basic local exchange telecommunications services granted to Accutel of Texas, Inc., in File Number TA-2000-410, is canceled.
2. Accutel of Texas, Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on October 10, 2011.

4. This case may be closed on October 11, 2011.
