ORDER CANCELING CERTIFICATE AND TARIFF

Issue Date: November 17, 2005 Effective Date: November 27, 2005

This order cancels the certificates of service authority to provide interexchange and basic local telecommunications services granted to American Farm Bureau, Inc., d/b/a The Farm Bureau Connection, along with its accompanying tariff.

On July 7, 2005, the Commission issued an order that permitted IBFA Acquisition Company, LLC to acquire the Missouri assets of American Farm Bureau, Inc., d/b/a The Farm Bureau Connection. As part of that order, the Commission directed IBFA Acquisition Company to inform the Commission when the authorized transaction was complete so that the Commission could cancel the certificates of service authority and accompanying tariff of American Farm Bureau, Inc., d/b/a The Farm Bureau Connection.

IBFA Acquisition Company and American Farm Bureau, Inc., d/b/a The Farm Bureau Connection filed a notice on November 14, indicating that the authorized transaction was completed on November 4, and that American Farm Bureau, Inc., d/b/a The Farm Bureau Connection has ceased operations in Missouri. The applicants again request that the

certificate of service authority and tariffs of American Farm Bureau, Inc., d/b/a The Farm Bureau Connection be canceled. On November 16, the Commission's Staff recommended that the Commission cancel the affected certificates and tariff.

Based on the request of the applicants, and on the recommendation of its Staff, the Commission will cancel the certificates and accompanying tariff.

IT IS THEREFORE ORDERED:

- 1. That the certificate of service authority to provide interexchange telecommunications services granted to American Farm Bureau, Inc., d/b/a The Farm Bureau Connection, in Case No. TA-97-99 is canceled.
- 2. That the certificate of service authority to provide basic local telecommunications service granted to American Farm Bureau, Inc., d/b/a The Farm Bureau Connection, in Case No. CA-2004-0131 is canceled.
- 3. That American Farm Bureau, Inc., d/b/a The Farm Bureau Connection's interexchange tariff, Missouri P.S.C. Tariff No. 1, is canceled.
 - 4. That this order shall become effective on November 27, 2005.
 - 5. That this case may be closed on November 28, 2005.

2.1. <u>Description and Limitations of Services</u>

- 2.1.1. Intrastate Telecommunications Service ("Service") is the furnishing of Company communication Services contained herein between specified locations under the terms of this Tariff.
- 2.1.2. Any member of the general public (including any natural person or legally organized entity such as a corporation, partnership, or governmental body) is entitled to obtain Service under this Tariff, provided that the Company reserves the right to deny Service: (A) to any Customer that, in the Company's reasonable opinion, presents an undue risk of nonpayment and refuses to comply with the deposit requirements set forth in Section 2.8.3, (B) in circumstances in which the Company has reason to believe that the use of the Service would violate the provisions of this Tariff or any applicable law or if any applicable law restricts or prohibits provision of the Service, or (C) if insufficient facilities are available to provide the Service (in such cases Company shall make best efforts to accommodate the needs of all potential Customers by means of facility improvements or purchases, of capacity, if such efforts will, in the Company's opinion, provide the Company with a reasonable return on its expenditures), but only for so long as such unavailability exists.
- 2.1.3. Company, when acting at the Customer's request and as its authorized agent, will make reasonable efforts to arrange for Service requirements, such as special routing, Diversity, Alternate Access, or circuit conditioning.
- 2.1.4. Service is offered in equal access exchanges subject to the availability of facilities and the provisions of this Tariff. Company reserves the right to refuse to provide Service to or from any location where the necessary facilities and/or equipment are not available.
- 2.1.5. Service may be discontinued after five business days written notice to the Customer if:
 - 2.1.5.A. the Customer is using the Service in violation of this Tariff; or
 - 2.1.5.B. the Customer is using the Service in violation of the law or Commission regulation.

- 2.1.8. The Company reserves the right to discontinue furnishing Services or billing options, upon written notice, when necessitated by conditions beyond its control. Conditions beyond the Company's control include, but are not limited to, a Customer's having Call volume or a calling pattern that results, or may result, in network blockage or other Service degradation which adversely affects Service to the calling party, the Customer, or other Customers of the Company.

By written notice, Company or Customer may change the party to receive notice and/or the address to which such notice is to be delivered. In the event no Customer or Company address is provided in the executed Service order, notice shall be given to the last known business address of Customer or, as appropriate.

2.2 Other Terms and Conditions

- 2.2.1. The name(s) of the Customer(s) desiring to use the Service must be stipulated in the application for Service.
- 2.2.2. The Customer agrees to operate the Company provided equipment in accordance with instructions of the Company or the Company's agent. Failure to do so will void the Company liability for interruption of Service and may make Customer responsible for damage to equipment pursuant to Section 2.2.3 below.
- 2.2.3. Customer agrees to return to the Company all Company-provided equipment delivered to Customer within five (5) days of termination of the Service in connection with which the equipment was used. Said equipment shall be in the same condition as when delivered to Customer, normal wear and tear only excepted. Customer shall reimburse the Company, upon demand, for any costs incurred by the Company due to Customer's failure to comply with this provision.

2.8. Payment Arrangements

- 2.8.1. The Customer is responsible for payment of all charges for Services furnished to the Customer or its joint or Authorized Users. the same by ordinance or otherwise, such taxes, fees or charges shall be billed to the end users receiving service within the territorial limits of such municipality. The amount of charge that is prorated to each Customer's bill is determined by the interstate or intrastate telecommunications service provided to and billed to an end user/customer service location in such a taxing jurisdiction with the aggregate of such charges equal to the amount of the tax or fee imposed upon or passed on to the Company.
- 2.11. Method for Calculation of Airline Mileage
- 2.11.1 The airline mileage between two cities can be calculated using the Vertical (V) and Horizontal (H) coordinates of the serving wire centers associated with the Company's POP locations. The method for calculating the airline mileage is obtained by reference to AT&T's Tariff F.C.C. No. 10 according to the following formula:
