ORDER SUSPENDING TARIFFS

Effective Date: August 5, 2014

On September 9, 2013, P.C.B, Inc., ("P.C.B") and M.P.B., Inc., ("M.P.B.") initiated small company revenue increase requests pursuant to Commission Rule 4 CSR 240-3.050. Staff, P.C.B, and M.P.B. later filed Disposition Agreements and conforming tariffs. The Office of the Public Counsel ("OPC") did not sign those agreements, and requested local public hearings. Thus, the Commission suspended those tariffs until August 10, 2014.

After the local public hearings, OPC stated that it still did not join in the Disposition Agreements. But OPC did not request evidentiary hearings, stating that new agreements would be forthcoming.

Those new agreements have not yet been filed, and OPC requests the Commission to suspend the tariffs until October 15, 2014. Commission Rule 4 CSR 240-2.080(15) allows parties ten days respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary, ten days have elapsed since OPC's request, and no party objects to OPC's request. Thus, the Commission will further suspend the tariffs.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel's motion to suspend is granted.
2. The following revised tariff sheets filed by M.P.B., Inc. on April 15, 2014, and assigned Tariff File No. YS-2014-0410, are suspended until October 15, 2014, or until otherwise ordered by the Commission:

3. The following revised tariff sheets filed by P.C.B., Inc. on April 15, 2014, and assigned Tariff File No. YS-2014-0411, are suspended until October 15, 2014, or until otherwise ordered by the Commission:

Canceling P.S.C. MO No. 2

4. This order shall become effective immediately upon issuance.
