ORDER CANCELING CERTIFICATES

Issue Date: May 12, 2023 Effective Date: June 11, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificate of service authority of Parta Networks, LLC (Parta Networks or the Company) to provide basic local exchange and non-switched local exchange telecommunications services in Missouri. In File Number CA-2020-0104, the Commission granted the Company a certificate of service authority to provide basic local exchange telecommunications services.

Staff's motion states that Parta Networks failed to submit an annual report due to the Commission for calendar year 2021. Staff recommended that the Commission cancel the Company's certificate of service authority. The Company has not responded to Staff's contacts to resolve these deficiencies.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff's motion, the fact that Parta Networks failed to submit its annual report for 2021, because the company cannot be reached by Staff, and has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to Parta Networks shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of service authority to provide basic local exchange and non-switched local exchange telecommunications services in Missouri, granted to Parta Networks, LLC in Case Number CA-2020-0104, is canceled.
 - 2. This order shall become effective on June 11, 2023.
 - 3. This case may be closed on June 12, 2023.
