ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFFS

Issue Date: June 11, 2008 Effective Date: June 21, 2008

On May 29, 2008, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariffs of Image Access, Inc. d/b/a NewPhone, a company that has been authorized to offer basic local and intrastate interexchange telecommunications services by the Commission.

In Case Number LA-2004-0444, the Commission granted NewPhone a certificate to provide basic local telecommunications services. In the same case, NewPhone's tariff, PSC MO No. 1, was also approved.

Also in Case Number LA-2004-0444, the Commission granted NewPhone a certificate to provide intrastate interexchange telecommunications services. In the same case, NewPhone's tariff, PSC MO No. 2, was approved.

Staff's motion states that on February 13, 2008, the Commission received a Statement of Revenue from NewPhone reporting zero revenue and the company requested the Commission cancel its certificate of service authority. In addition, the company no longer provides services to customers in Missouri, owes no past assessments to the Commission.

Staff recommends that the Commission cancel the company's certificate of service authority to provide basic local and intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on NewPhone's request, Staff's motion, and because NewPhone is not providing telecommunications service in Missouri, the Commission finds that the certificate of service authority granted to Image Access, Inc. d/b/a NewPhone, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide basic local telecommunications services granted to Image Access, Inc. d/b/a NewPhone, in Case Number LA-2004-0444, is canceled.
- 2. NewPhone's tariff, PSC MO No. 1, also granted in Case Number LA-2004-0444, is canceled.

- 3. The certificate of authority to provide intrastate interexchange telecommunications services granted to Image Access, Inc. d/b/a NewPhone, in Case Number LA-2004-0444, is canceled.
- 4. NewPhone's tariff, PSC MO No. 2, also granted in Case Number LA-2004-0444, is canceled.
 - 5. This order shall become effective on June 21, 2008.
 - 6. This case may be closed on June 22, 2008.
