**ORDER GRANTING APPLICATION**

Issue Date: October 17, 2013

Effective Date: November 1, 2013

The Missouri Public Service Commission is granting the application for recognition of the following name change:

From: Liberty Energy (Midstates) Corp. d/b/a Liberty Utilities

To: Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities

The Commission is also approving the tariff sheets filed with the application.

The Commission received the application with tariff sheets on October 2, 2013, and a substitution on October 15, 2013. On October 17, 2013, the Commission’s staff filed its recommendation in favor of granting the application, and approving tariff sheets, or allowing them to take effect by operation of law. Because no party disputes the application, no law requires a hearing before granting the application, so the Commission convened no hearing and bases its findings on the verified filings.<sup>1</sup>

Therefore, the Commission will grant the application and recognize the name change. The Commission will also approve the tariff sheets as substituted. The tariffs’

proposed effective dates and the unopposed resolution of this action constitute good cause for this order's effective date to be less than 30 days from this order's issuance date.<sup>2</sup>

**THE COMMISSION ORDERS THAT:**

1. The following name change is recognized:

From: Liberty Energy (Midstates) Corp. d/b/a Liberty Utilities

To: Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities

2. Tariff Tracking No. YG-2014-0157 is approved to take effect on November 1, 2013.
