a. Community Optional Service (COS) is an optional plan that allows customers in a qualifying COS Petitioning Exchange to purchase intraLATA interexchange calling with customers in designated exchanges, known collectively as their COS Calling Scope, under terms, conditions and rates as found in the Company Tariff(s). The COS Calling Scope consists of the COS Target Exchange to which COS Petitioning Exchange customers have qualified for COS calling, plus all other exchanges with which customers in the COS Target Exchange have Extended Area Service (EAS).

2. Qualification Process

- a. In order to qualify, customers in one exchange, known as the COS Petitioning Exchange, must demonstrate that a community of interest exists with customers in the exchange with which they desire COS calling, known as the COS Target Exchange. Consideration of elgibility for COS calling is initiated by a petition filed with the MPSC by any or all of the following parties:
 - 1) By 25 or more customers in the COS Petitioning Exchange;
 - 2) By the presiding official(s) of a city, town, village or county, within the COS Petitioning Exchange;
 - The Office of the Public Counsel on behalf of the customers in the COS Petitioning Exchange;
 - 4) The company serving the customers in the COS Petitioning Exchange.
- b. If the petitioning COS Exchange has failed the calling study criteria, the exchange can reapply or repetition for the service after two (2) years.
- c. COS will not be offered between Metropolitan Calling Area (MCA) exchanges as defined in the Missouri Public Service Commission (MPSC) Order, effective January 5, 1993, in Case #TO-92-306.
- d. Petitions requesting COS must specify the COS Target Exchange with which COS calling is requested. The COS Target Exchange may be served by another local exchange company.
