ORDER APPROVING TARIFF

Effective Date: January 4, 2018

On September 7, 2017, Missouri-American Water Company (“MAWC”) filed an application with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it a Certificate of Convenience and Necessity (“CCN”) to install, own, acquire, construct, operate, control, manage and maintain a sewer system in St. Louis County, Missouri. The requested CCN would allow MAWC to provide water service to an existing development known as Radcliffe Place. The Commission granted that application on December 6, 2017.

On December 28, 2017, MAWC filed the above-denominated tariff to comply with the Commission’s December 6, 2017 order. That tariff bears an effective date of January 27, 2018. MAWC also filed a substitute tariff sheet on January 3, 2018.

MAWC also filed a Motion for Expedited Treatment with its tariff. In the motion, MAWC asks for the tariff to become effective on January 8, 2018. MAWC explains that the transaction allowing it to buy Radcliffe Place will become effective on January 8, 2018. Thus, a tariff effective date of January 8, 2018 will reduce or eliminate any gap between the Radcliffe Place purchase and the effective date of the tariffs under which MAWC would serve Radcliffe Place customers.

Staff filed a Recommendation on January 3, 2018, in which it stated the Commission should approve the tariff to go into effect on January 8, 2018. The Commission allowed other parties to respond no later than January 3, 2018, but the Commission received no other responses.

The Commission has reviewed the tariff filing and Staff's verified recommendation. The Commission will approve the tariff sheet to take effect on January 8, 2018.

THE COMMISSION ORDERS THAT:

1. The Motion for Expedited Treatment is granted.
2. The tariff sheet filed on December 28, 2017, as substituted on January 3, 2018, by Missouri-American Water Company, Tariff Tracking Number YS-2018-0079, bearing the effective date of January 27, 2018, is approved to become effective on January 8, 2018.
3. This order shall be effective on January 8, 2018.

4. This file shall be closed on January 9, 2018.
