Dear Judge Woodruff,

On behalf of Missouri-American Water Company ("MAWC" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing certain tariff sheets in electronic form consisting of revised water and sewer tariff sheets. The proposed tariff sheets are listed on Appendix A, bear a date of issue of July 1, 2022, and an effective date of July 31, 2022.

The purpose of this filing is to implement a general rate increase for water and sewer service provided by MAWC. The revised rates are designed to produce \$99.6 million in additional annual water and sewer revenues (excluding gross receipts and sales taxes) or a 25.7% increase over revenues authorized in MAWC's last general rate case (WR-2020-0344) and subsequent WSIRA cases (WO-2021-0428 and pending in WO-2022-0176).

The water rates have been designed to implement the Company's proposal to move to consolidated tariff pricing. Provided herewith as Appendix B is a description of the impact MAWC's proposal would have on residential customers in each district utilizing 3,000, 5,000, and, 7,000 gallons monthly usage levels.

Notes:

- For residential customers with a 5/8 inch water meter, the proposed rates include a fixed charge of \$12.00 for monthly customers and \$36.00 for quarterly customers

- For all residential water customers, the proposed rates includes a volumetric rate of \$8.5672 per 1,000 gallons of water, in addition to the meter charge.

- Current water rates include WSIRA of \$0.4828 per 1,000 gallons for St. Louis County customers and \$0.2559 per 1,000 gallons for other water customers.

- Current sewer rates include WSIRA of 0.677% of the total bill for Arnold customers, and 2.588% of the total bill for other wastewater customers.

- For all Arnold sewer customers, the proposed fixed charge of \$37.50 includes 5,000 gallons, with additional usage at \$7.1880 per 1,000 gallons.

- For all Other Missouri sewer residential customers the company is is proposing flat rates of either \$66.70 or \$49.65 , depending on the service area.
