ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 11, 2008 Effective Date: January 21, 2008

On December 11, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of Telliss, LLC to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri.

In Case Number TA-2002-474, the Commission granted Telliss a certificate of service authority to provide intrastate interexchange and non-switched local exchange telecommunications services. Telliss' tariff, P.S.C. Mo. Tariff No. 1, was approved in the same case. Telliss has asked the Commission, through a letter from its CEO, to cancel its certificate of service authority.

Staff's motion states that Telliss sold its Missouri operations to First Choice Technology Inc. and no longer does business in Missouri.

Staff's Motion indicates Telliss owes no annual reports or assessments. No formal complaints have been filed against the company since the commencement of the Electronic Filing and Information System, and any informal complaints or inquiries received have been closed.

Because Telliss has requested cancellation of its certificate, and is not providing telecommunications service in Missouri, Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange and non-switched local exchange telecommunications services and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the request from the company's CEO and Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Telliss shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange and non-switched local exchange telecommunications service, granted to Telliss, LLC in Case Number TA-2002-474, is canceled.
 - 2. Telliss' tariff, P.S.C. Mo. Tariff No. 1, is canceled.
 - 3. This order shall become effective on January 21, 2008.

4. This case may be closed on January 22, 2008.
