(15) Mobility National Retail Service Connection Charge Waiver

New customers, who choose the Company as their local service provider and place an order for new residential local exchange service in person at a retail location with whom the Company has an arrangement to sell its services, will receive a waiver for the Installation charges for residence exchange access line. New customers must order a minimum of Complete Choice Basic. Existing customers are not eligible for this waiver.

- (16) \$5 X 12 Residence Access Line Retention – Beginning October 1, 2011 through July 4, 2012, eligible residence customers who call to disconnect their access line(s) and decide to retain the line(s) will receive a \$5.00 bill credit per month, per line for up to two access lines, for a maximum of 12 months. (CT)

- Eligible customers may only receive this offer once during the offer period.
