Enclosed for filing is <u>P.S.C. MO. No. 8 Consolidated, First Revised Sheet No. 12,</u> which is applicable to the Spire Missouri West operating unit of Spire Missouri, Inc. ("Company").

This revised tariff sheet, which has an issue date of June 7, 2018 and an effective date of July 7, 2018, is being filed to establish an Infrastructure System Replacement Surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri. A full explanation of the surcharge being proposed by the Company is set forth in the VERIFIED APPLICATION AND PETITION OF SPIRE MISSOURI INC. TO ESTABLISH AN INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE FOR IT'S SPIRE MISSOUI WEST SERVICE TERRITORY, which is being filed separately today. As proposed herein, the ISRS would increase the typical residential heating customer's bill by \$1.04 per month or less than 1%.

INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE ISRS

Description: Rate ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of sections 393.1009, 393.1012 and 393.1015, RSMo.

Applicability: Rate ISRS is applicable to each customer billing for service during the effectiveness of the ISRS rate element.

ISRS Rate Element: In addition to the other charges provided for in the Company's tariff, a monthly ISRS Rate Element shall be added to each bill for service on and after the effective date of the ISRS rate. The amount of the ISRS Rate Element, by customer class, is as follows:

Residential	\$1.04	per	month	*
Small General Service	\$1.56	per	month	*
Large General Service	\$6.79	per	month	*
Large Volume Service	\$57.10	per	month	*
Intrastate Transportation Service	\$0.00 per month			*
