**ORDER CANCELING CERTIFICATES AND TARIFFS**

Issue Date: May 30, 2007

Effective Date: June 9, 2007

On May 10, 2007, the Staff of the Missouri Public Service Commission filed an application requesting the Commission cancel their certificates of service authority and tariffs to provide basic local telecommunications services and interexchange telecommunications services, as well as non-switched local exchange telecommunications services, limited to providing dedicated private line services telecommunications services.

In Case Number TA-2002-453, the Commission granted CD Telecommunications a certificate of service authority to provide basic local telecommunications services in the State of Missouri. CD Telecommunications' tariff, PSC Missouri Tariff Number 2, was approved in Case Number CT-2003-0250.

In Case Number XA-2004-0506, the Commission granted CD Telecommunications a certificate of service authority to provide interexchange telecommunications services, as well as non-switched local exchange

telecommunications services, limited to providing dedicated private line services telecommunications services. CD Telecommunications' tariff, P.S.C. MO No. 1, was also approved.

On April 27, 2007, CD Telecommunications, through a letter from its president, asked the Commission to cancel its certificates of service authority and tariffs because it is no longer providing service in Missouri and does not intend to do so in the future.

CD Telecommunications has no assessments past due, nor does it owe any annual reports other than the 2006 annual report, which was due April 15, 2007. Since the commencement of the Commission's Electronic Filing and Information System, no complaints submitted by customers regarding the company are unresolved.

Because CD Telecommunications has requested cancellation of its certificates and because it's not providing telecommunications service in Missouri, Staff recommended the Commission cancel CD Telecommunications' certificates of service authority.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on CD Telecommunications' request to cancel its certificates and tariffs and Staff's recommendation, the Commission finds that the certificates of

service authority and tariffs granted to CD Telecommunications shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide basic local telecommunications services granted to CD Telecommunications, LLC, in Case Number TA-2002-453, is canceled.

2. CD Telecommunications, LLC's tariff, PSC Missouri Tariff Number 2, is canceled.

3. The certificate of authority to provide interexchange telecommunications services as well as non-switched local exchange telecommunications services, limited to providing dedicated private line services telecommunications services granted to CD Telecommunications, LLC, in Case Number XA-2004-0506, is canceled.

4. CD Telecommunications, LLC's tariff, P.S.C. MO No. 1, is canceled.

5. This order shall become effective on June 9, 2007.

6. This case may be closed on June 10, 2007.
